III. NEW BUSINESS / ACTION (5:42-6:51)

A. Community Safety – Erin Gore, SVC Finance & Administration

- Patients often have difficult navigating the UCSF campus. Multiple strategies to assist patients in finding their destinations, including language services will be considered.
- Students require comprehensive resources to ensure their personal safety, particularly in the context of varying ideologies or political environments. Students are encouraged to speak to the Dean. A variety of resources are available for safety, campus police, free Lyft services, and walking safety escorts.

B. RCO Funding Guidelines Proposal: Category for Recreational/Sport Activities – Aunoy Poddar

- The majority of sports-related events take place off-campus, and participating in these activities generally requires minimal equipment.
- It is proposed that the funding guidelines include an annual cap on funding for each group, with flexibility in the cost per event.
- The draft of the proposed funding guidelines suggests an annual budget of \$1,500, which would cover equipment, court rentals, and food/beverages.
- Adjustments to these guidelines will be considered at the end of the year based on their performance and feedback.
